## Election Notification 2022, ISA Delhi Branch,

Dear Delhi ISAians,

As per the directive from the ISA National HQ, ISA Delhi will be conducting the elections for various posts as below:

1. **President ISA DELHI – ONE Post**
2. **Vice-President ISA DELHI – ONE Post**
3. **Editor ISA DELHI – ONE Post**

The Chief Election officer for this election will be **Dr Nikki Sabharwal**, Immediate Past President ISA Delhi and **Dr . Rajiv Gupta**, ISA National Governing Council member, will be the Observer.

### ELIGIBILITY CRITERIA FOR CANDIDATES:

At the time of filing nominations

- A. The Candidate should be duly qualified Anaesthesiologist.
- B. The candidate should be a Life-member of the ISA and her/his membership should be currently active.
- C. Contestant must be a continuous member of the ISA for not less than TEN years for the posts of President and Vice-president and not less than FIVE years for the post of Secretary, Treasurer and Editor.
- D. Contestant for the posts of the President preferably should have served one term of ISA office earlier.
- E. The candidate must have attended at least 2 ISA National / ISA Delhi state annual conferences in last 5 years

### OR

- Should have attended at least three, monthly clinical meetings in last one year, other than own institution.
- F. The proposer and the seconder should be Active life members of the Indian Society of Anaesthesiologists, and their names should appear in the Valid Voter list of the ISA.
  - G. The tenure of The President, Vice-President and Editor is ONE year

**The Timelines for the whole election process are as follows:**

1. Issuing of Notification **21 June 2022**
2. Last Date to Receive Nominations 5.00 PM of **30 June 2022**
3. List of Valid Nominations received will be published on **2 July 2021 ISA Website**
4. Last Date of Withdrawal of Nomination **7 July 2021**
5. Final list of Eligible candidates will be published on **8 July 2021 on ISA Website.**
6. Online voting, if required, will be open for five days, from **16 July (08:00 AM) to 20 July 2021 (05:00 PM).**
7. The final details of votes polled will be published and the result will be declared **immediately after voting is closed on 20 July 2021.**
8. Only Active ISA Members are eligible to Vote. The updation of mobile number or e-mail ID of Associate Life members and Inactive members can be done till **30 June 2022.** The final voter lists (online only) will be published in the ISA Website (www.isaweb.in) on **30 June 2022.**

**Instructions for Candidates filing nominations:**

1. Please attach your Curriculum Vitae (Not more than 250 words)
2. The nomination of candidates to the election shall be made in the prescribed format, which is enclosed. Every nomination together with the written consent of the candidate to contest the election duly proposed by one and seconded by another Active ISA Life Member shall be sent to the Honorary Secretary, ISA Delhi Branch to reach him not later than 5:00 PM on 30<sup>th</sup> June 2022. Incomplete Nominations will be rejected
3. Nomination fees for President and Vice-President is Rs. 1500/- (Fifteen Hundred Only) for all other posts it is Rs.1000/-(One Thousand Only)
